2. Restrictions:

Any entities with an existing unresolved dispute with ACB or any other ICC Member Countries on a point of law or fact shall be ineligible to participate in the tender process and submit bids.

This Financial offer excludes the Ground branding Cost (Production, Maintenance & Labor) and Prize money awards.

Bid Documents Submission deadline is 11.59 PM, 31st December 2021. The bids will be opened, evaluated and tender awarded. All terms and conditions related to the tender submission and evaluation of bids eligibility require-ment and performance obligations are available in the document.

ACB reserves the right as per discretion, to cancel or amend the entire bidding process at any stage and to reject any or all bids without being obliged to assign any particular reason for the same.
